We also have to request your specific consent to our filing from time to time a Form 8966 FATCA Report relating to you with the IRS. As a legal entity, please be aware of the notion of "Substantial US owner" described specifically in US Regulations. If applicable to you, FATCA reporting is also due. Please note that, should such consent not be obtained from you, we shall not be able to accept your subscription.
